**Explanation of Responses:**

- Each restricted stock unit ("RSU") represents a contingent right to receive one share of class A Common Stock
- These securities are directly held by Replogle Family LLC, for which the Reporting Person serves as manager.
- These RSUs vested 30% on November 15, 2022, and then 7.5% for each subsequent quarter of continuous service for the following year and then 5% for each subsequent quarter of continuous service for the following two years.
- The RSUs have no expiration date.
- These RSUs vest approximately as follows: with respect to 201,039 RSUs, 15,459 vested and settled on November 15, 2022, and the rest will vest in equal installments on each February 15, May 15, August 15 and November 15 until becoming fully vested on November 15, 2025, subject to the Reporting Person's continued service with the Issuer through each applicable vesting date.
